BUYER agrees to the following-

This cat/kitten is purchased for pet purposes and must be spayed by 6-8 months or neutered by 8 months. This cat MAY NOT be used for BREEDING Purposes. Any offspring produced by this cat/kitten becomes property of Lynzkatz Cattery. As all male kittens testicles descend at different rates, any and all costs of neutering are the pet buyer's responsibility. A neuter/spay certificate is required to be sent by the buyer to the seller by the time the cat/kitten is 10 months old. We prefer our cats/kittens not be declawed.

This cat is healthy and current on all vaccinations unless purchaser is told otherwise. All follow-up Vaccinations and any and all other veterinary health care are the responsibility of the buyer including costs of spaying and neutering. This cat/kitten is guaranteed to come from a Feline Leukemia/Feline Aids negative household. This cat/kitten is guaranteed for six months against terminal genetic defects. If that is proven by a veterinarian, the seller will give the buyer another cat or kitten as a replacement. Refunds are not given.

Adequate indoor facilities must be provided and the cat/kitten may not be allowed to roam outdoors. If the cat/kitten has to leave the house for any reason (i.e. the veterinarian), it must be transported in a cat carrier. Under no circumstances will the buyer sell, lease, trade, give away or otherwise transfer the possession or care of this cat/kitten to another party without the express written permission of the seller.

Buyer understands that a \$ \_\_\_\_\_ deposit WILL NOT be refunded, if the cat/kitten is returned for any reason other than genetic health of the cat/kitten. Breach of contract penalty is \$500.00 per item. It is mutually understood that failure to comply with any provision of this contract may detrimentally affect the reputation and business of Lynzkatz Cattery. Any legal action which may arise under the terms of this contract will be brought in the court of Blair County, Pa. Pennsylvania laws will be applied to any dispute under this contract. Buyer will be liable for any court costs and related charges associated with the seller enforcing the terms of this contract. Seller retains a security interest in this cat/kitten for purposes of enforcement of this contract, and may enforce that action without judicial intervention.
